NOTIFICATION

Subject : Guidelines related to Minors

1. The salient features of Minor are

- (a) A student who wishes to pursue a **Minor from other discipline** must earn 24 credits (out of the total 48 credits to be earned from elective courses) from the basket prescribed for that particular Minor. The remaining 24 credits must be earned from the DEC's of the discipline to which the student is pursuing his/her UG degree.
- (b) A student who wishes to pursue a **Minor from the own discipline** must earn 20 credits (out of the total 48 credits to be earned from elective courses) from the basket prescribed for a particular Minor. The remaining 28 credits may be earned from the DEC's/GEC's.
- (c) A student not keen to pursue a Minor must earn at least 24 to 28 credits (out of the total 48 credits to be earned from elective courses) from the DEC's of the discipline in which the student is pursuing his/her UG degree. The remaining credits (24 or 20) may be opted from DEC's/GEC's.
- (d) Out of 48 Credits of DEC's/GEC's, a student may earn 8 credits from the following:-

- (i) **MOOCs**: Provided that the MOOC opted should be relevant to DEC/GEC courses of the University.
- (ii) **Short Term/specialized Courses** attended within or outside the University like GIAN, SPARC etc. as per the provisions of AC agenda no. 24.11 approved by AC in its 24th meeting held on 29/7/2020.


(e) A student shall not be allowed to opt for Two Minors in any case.

2. With respect to above framework of Minor following are the guidelines for its implementation. These are applicable only for the students admitted from Ay 2019-20 onwards.

- (a) During registration of courses for IV semester of B Tech programme students will be asked to submit option (Yes/No) for pursuing Minor from V semester onwards.
- (b) All HODs will appoint one faculty coordinator for each Minor in their discipline. The coordinator shall act as advisor to the students for all matters pertaining to that Minor.
- (c) Students studying in V semester can register core/electives courses of their own or other disciplines from previous as well as forthcoming semesters. However, a student can register to a maximum of 32 credits only in a semester.
- (d) While registering for courses student should ensure that the courses registered by him/her meet the requirement prescribed in Para (a),(b)and (c) above.
- (e) MOOCs can be taken against DEC/GEC/electives of Minor.
- (f) If a student has already earned credits for a course from MOOCs /Short Term/specialized Courses and its syllabus is similar to a course of a Minor

the/she wishes to opt for, then an Equivalence Committee may examine and recommend for counting these credits towards requirement of Minor. The Constitution of Equivalence Committee shall be


- (i) HoD's of department offering Minor
 - (ii) Head of Department in which student is enrolled
 - (iii) Coordinator of the course.
- (g) Further, as per the orders of the Honorable Supreme court it is mandatory for all UG students to take a course on environmental studies (EVS). Therefore, if a student who could not register any course on EVS through FEC in first four semesters he/she can take an EVS related MOOC of 2 credits (out of total 8 credits which can be earned from MOOCs) against his/her DECs/GECs.
